1. Principal is not regularized under Statute-19.
2. Adhoc/contract basis faculties are to be regularized under Statute-19.
4. Associate Professor and Professor are to be appointed to meet the norms.
3. Inadquate no. of printers
4. Revised Pay scale is not given to the faculties.
5. Cadre ratio is not maintained as per norms.
6. Computer systems are required to be upgraded.
7. barrier free built environment is not provided.
8. Medical facility is to be improved.
9. Safety measures are to be provided in Elect. Labs.
10. Mech Engg. Labs & EE labs of 1st year should be shifted in 1st year block from other block.
11. Precaution for DC power supply line should be notified.
12. AC to DC rectifier should be properly guarded.
13. Heavy motors and or MG sets should not be placed behind panels

The compliance of the above deficiencies should be communicated to the University before the commencement of academic session.
