In compliance with the instructions of National Commission for women and guidelines issued in implementation of the directives of Hon'ble Supreme Court Judgement dated 13th August, 1997 in the case of Visakha and others vs. State of Rajasthan and Others on the subject of sexual harassment of women in the workplace, CCET had duly constituted a Complaint Committee for considering complaints of sexual harassment of women working in the Institution. This Committee has been constituted on 12th July, 2016 for considering complaints of sexual harassment of women employees.

Internal Complaints Committee (ICC)

A committee constituted by CCET promotes a healthy working environment to all CCET female staff, students and faculty.

In accordance to Section 29 of the Sexual Harassment of women at Workplace (Prevention, Prohibition and Redressal) Act, 2013 (14 of 2013) and OM dated 21.07.2009 in F.No.11013/3/2009-Esst.(A) issued by the Deptt. of Personnel & Training, Govt. of India, CCET has constituted an Internal Complaints Committee (ICC) to conduct enquiry regarding harassment cases.

Any CCET female employee (faculty or staff) or student

Definition of Sexual Harassment:

"Sexual harassment" includes such unwelcome sexually determined behavior, whether directly or otherwise, as:

- Physical contact and advances
- Demand or request for sexual favors
- Sexually colored remarks

- Any other unwelcome physical, verbal or non-verbal conduct of a sexual nature

What are the possible actions that can be taken against the respondent?

- Warning
- Written apology
- · Bond of good behavior
- Adverse remark in the Confidential Report
- Stopping of increments/promotion
- Suspension
- Dismissal
- Any other relevant mechanism

If you are harassed, what should you do?

Inform to immediate supervisor or any other person in authority if the complaint is against the supervisor or WGRC-ICC

Rest assured that your complaint will be kept CONFIDENTIAL.

Inquiry into complaint:

- The inquiry shall be complete within a period of ten days from the date of the complaint.
- On completion of the inquiry, the Internal Committee shall provide a report of its findings to the
 Executive Vice Chairman / Principal within a period of seven days from the date of completion of
 the inquiry and such report be made available to the concerned parties.
- If the allegation against the respondent has been proved, it shall recommend punitive actions to be taken against the respondent to the employer.
- The employer shall act upon the recommendation within thirty days of its receipt by him.
